BREAKING NEWS: FCC CHAIRMAN TOM WHEELER STEPPING DOWN

The top regulator of communications in the U.S. would resign his post. FCC Chairman Tom Wheeler, an Obama appointee who championed the net neutrality policy, said his last day would be Jan. 20, the day Donald Trump takes the oath of office. The long-term impact on the agency and its regulations is the subject of speculation. Wheeler's departure leaves a tilted balance with fewer Democratic than Republican commissioners. A spokesman for Democrat Mignon Clyburn said on Thursday, Dec. 15 that her plan is to serve until mid-2017 when her term expires. Liberal Commissioner Jessica Rosenworcel's term has ended and she is expected to leave the FCC by Dec. 31. As president, Trump will appoint Wheeler's successor.

SSTV: RADIO FOR YOUR EYES AS WELL AS EARS

: As hams celebrate the 18th anniversary of the activation of a Slow Scan TV System aboard Russia's now-deorbited MIR Space Station, another SSTV enthusiast - this one in Hawaii - has created a project giving hams a closer look at what the mode can do.

While Slow Scan TV isn't anything new on the HF bands, Darren Holbrook KH6OWL, an enthusiast in Honolulu, Hawaii, has added something new to the mix: a website that shares some recent Slow Scan TV images sent to him from around the world on 20 meters. It's an online gallery of about a dozen or so pictures and it invites visiting hams to explore this mode of image

- Treasurer: Treasurer's report read and submitted.
- <u>Repeater/Equipment</u>: No issues reported with any 2M or 440MHz repeaters. Provided Ken, K3UQQ, with input power spec for ATV repeater amp (7W peak for D1010ATV Repeater Amplifier).

Discussed the imperative need to coordinate all visits to work on repeaters and ATV equipment at N. Balto. location.

Ken was asked to provide email report of recent work done. There is confusion over the state of the antenna on the non-pen mount (mount has a leak).

- <u>IOTA</u>: Discussed possible improvements and operating options for 2017. Will
 explore using K3SAV fan dipole and foredeck operation. Ongoing issues with
 noise on ship's vertical argue against its use. Will coordinate with Cliff at NSS to

- <u>Repeater Software Stack</u>: Oryx is progressing with new software to replace cumbersome Asterisk package. Capable of running on all but early RaspberryPi processors. Much improved voting function due to improved front end signal analysis. COS/CSQ in place; PL support needs to be developed.

- Equipment Installations: new 440MHz and 2M Tx, along with 2M amp, await installation.

Rep. Greg Walden, W7EQI, to Chair Powerful House Energy and **Commerce Committee**

US Rep. Greg Walden, W7EQI (R-OR), who championed the Amateur Radio Parity Act (H.R. 1301) as the chair of the Subcommittee on Communications and Technology, will chair the US House Energy and Commerce Committee when the 115th Congress convenes in January. Energy and Commerce is considered one of the most powerful congressional panels on Capitol

Walden gained favor within the Republican Party after serving two terms as head of the National Republican Congressional Committee. The nine-term Oregon lawmaker, had campaigned around the country with Speaker Paul Ryan (R-WI) during the run-up to the November election, and Walden's selection to head Energy and Commerce over a more senior colleague is being considered recognition of his role in the GOP's election successes. Ryan spoke in favor of Walden's candidacy to head Energy and Commerce.

After the vote, Walden praised Shimkus and Barton as "good friends" and "excellent legislators."

During a Capitol Hill hearing last January, Walden, a cosponsor of H.R. 1301, called the measure "a commonsense bill" and urged his colleagues to support moving the measure forward to the full committee. In July, Walden had recommended the amended version of the bill to his colleagues as "a good balance." The bill now awaits action in the U.S. Senate. Walden represents Oregon's second Congressional district.

Amateur Radio Parity Act Bill Unable to Overcome Florida Senator's Objections:

The Amateur Radio Parity Act, H.R. 1301, suffered an unbefitting demise on December 9 as the 114th Congress drew to a close. After passing the House of Representatives on a unanimous vote earlier this fall, the bill stalled in the Senate due to the intervention of only one member, Sen. Bill Nelson (D-FL). The measure would have directed the FCC to extend its rules relating to reasonable accommodation of Amateur Service communications to private land-use restrictions, such as covenants, conditions, and restrictions (CCRs) imposed by homeowners associations.

In a final meeting with Nelson's staff as the 114th Congress neared adjournment, it became clear that no matter what was said or done, the Senator would oppose the bill and refuse to allow it to move forward. Because the measure had not been put on the floor schedule, the only way it could have passed the Senate would have been through a process called "unanimous consent." A Senate member may request unanimous consent on the floor to set aside rules and expedite proceedings. If any single Senator objects, though, the request is rejected.

The unhappy ending followed nearly 2 years of intense effort on the part of ARRL and thousands of its members, who contacted their Congressional representatives to urge their support of the measure on Capitol Hill. The ARRL Board of Directors is expected to discuss the fiture of "e initiative at its January meeting.


